## Employer's strategies to help workers overcome woes caused by inflation anxiety 高通脹增添僱員焦慮 僱主良策助員工解困

High inflation has become a pressing global issue and has perplexed workers. 80% of Hong Kong workers felt stress due to the impact of elevated inflation, Fidelity's annual Global Sentiment Survey revealed. One can imagine how prices are exacerbating the cost-of-living crisis for ordinary people – detrimentally impacting well-being, financial habits, and retirement planning.

Bringing together industry experts across human resources and retirement, the seminar will highlight the challenges faced by the city's workers and share solutions that HK employers can consider, to support the well-being and financial wellness of their employees - and ultimately help them better plan for retirement.



Charlotte brings over 20 years of experience in investment advice, focusing on managed solutions for both institutional and individual clients for their pensions and private wealth. She has held various roles at Fidelity, including Portfolio Strategist for North Asia intermediary business, Director for Hong Kong defined contribution business where she focused on business development and client relationships, and investment directing for the Hong Kong institutional business.
